In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, does hereby act an incorporator in adopting and filing the following articles of incorporation for the purposes of organizing a business corporation in Florida.

ARTICLE I.

The name of the Florida Corporation is The Legal Outlines Publishing Company.

ARTICLE II.

The existence of the corporation shall begin on the date on which these Articles of Incorporation are first filed with the Department of State of Florida and shall be perpetual thereafter. The purpose of this Florida Corporation is to engage in the publishing and selling of legal outlines for law students.

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

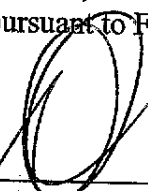
