The undersigned incorporators to these Articles of Incorporation hereby associate to form a corporation (the "Corporation") under Chapter 607 of the Florida Statutes.

1. Name

The name of the Corporation is Fit Together Family Athletic Center, Inc. The Corporation's principal office (and mailing address) is located at 15771 Waite Island Drive, Fort Myers, Florida 33908 in Lee County, Florida. The Board of Directors may from time to time move the principal office of the Corporation to any other address in the State of Florida.

2. Nature of Business

The Corporation is formed to engage or transact in any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

3. Powers

The Corporation shall have the power, either directly or indirectly, either alone or in conjunction or in cooperation with others, to do any and all lawful acts and things and to engage in any and all lawful activities which may be necessary, useful, desirable, suitable or proper for the furtherance, accomplishment, fostering or attainment of any or all of the purposes for which the Corporation is organized.

4. Capital Structure

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is Ten Thousand (10,000) shares of common stock having One Dollar (US\$1.00) par value per share.

5. Term of Existence

The date when corporate existence shall commence shall be the date of filing of these Articles of Incorporation in the office of the Secretary of State of the State of Florida, and the Corporation shall have perpetual existence thereafter.

6. **Incorporators**

The names and addresses of the incorporators of these Articles of Incorporation are: Susan M. Savage, 15771 Waite Island Drive, Fort Myers, Florida 33908; Teryl Redwine, 11270 Jacana Court, #2110, Fort Myers, Florida 33908; and John J. Masucci, 9646 Halyards Court, #21, Fort Myers, Florida 33919.

7. **Initial Registered Office and Agent**

The street address of the initial registered office of the Corporation is 11270 Jacana Court, #2110, Fort Myers, Florida 33908, and the name of the initial registered agent at such address is Teryl Redwine.

8. **Directors**

The affairs of the Corporation shall be managed by a Board of Directors, members of which shall be elected in accordance with Bylaws adopted for the Corporation. The first Board of Directors, consisting of those persons who shall serve until their successors are duly elected and qualified, shall be appointed by the incorporators pursuant to Florida Statutes Section 607.0205.

9. **Officers**

The Corporation shall have officers as provided in Bylaws adopted for the Corporation.


10. **Bylaws**
