ARTICLES OF INCORPORATION

FIRST. The name of the corporation is For the Sake of Our Grandchildren, Inc.

SECOND. The street address of the initial principal office of the corporation is 14414 Dulcimer Court, Orlando, FL 32837.

THIRD. The total number of shares of all classes of stock which the corporation shall have authority to issue is 1,100 of which 1,000 shares of par value \$1.00 per share shall be designated as Common Stock and 100 shares of par value \$1.00 shall be designated as Preferred Stock. 
