ARTICLE XII – OFFICERS

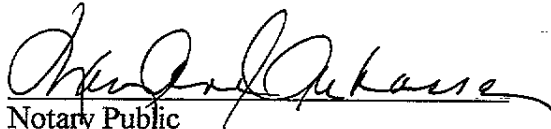
