ARTICLES OF INCORPORATION
OF
ROFTEL CORPORATION

ARTICLE I - NAME

The name of this Corporation is ROFTEL CORPORATION
initial address: 1811 White Heron Bay Circle, Orlando, Florida 32824.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on May 24, 2002.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted
under the laws of the United States and of the State of Florida.


