The undersigned incorporators of these Articles of Service First Lawn Care, Inc., each a natural person competent to contract, associate themselves together to F STATE form a corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation Service First Lawn Care, Inc.
