

Article I. Name and Address

The name of this corporation is McKenna Enterprises, Inc.. The address of the corporation and the principal office of this corporation is 3165 Novus Street, Sarasota, FL 34237.

Article II. Duration

This corporation shall exist perpetually commencing 5 days prior to the date of filing of these articles.

Article III. Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV. Capital Stock

This corporation is authorized to issue 100 shares of \$1.00 par value common stock.

Article V. Preemptive Rights

Every shareholder, upon the sale for cash of any authorized and unissued stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at


Article X. Indemnification


