ARTICLES OF INCORPORATION OF LAW OFFICES OF RICHARD G. OZELIE

The undersigned, acting as incorporator of a Florida corporation under the Florida Professional Service Corporation Act, Chapter 621 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I NAME
