The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the Corporation shall be PA & SH ENTERPRISES OF ORLANDO, INC. The corporation shall do business as (DBA) ARCADE.

ARTICLE II: PRINCIPAL OFFICE
