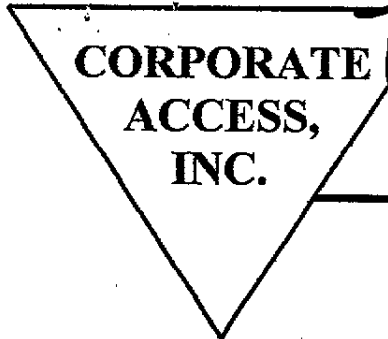


ARTICLE IX. INDEMNIFICATION
