All officers, agent and factors shall be chosen in such manner, hold their office for such terms and have such powers and duties as may be prescribed by


the By-Laws or determined by the Board of Directors of the corporation.

The right to indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled as a matter of law.

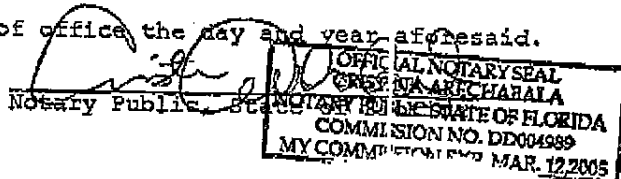
