AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

6340 SUNSET CORP.

1. Pursuant to the provisions of Florida law, the undersigned Corporation adopts the following Amended and Restated Articles of Incorporation:

ARTICLE I

The name of the corporation is 6340 SUNSET CORP.

ARTICLE II Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 29th day of May, 2002.

ARTICLE III Purpose

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE IV Capital Stock

The Corporation is authorized to issue two (2) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class A Voting Common Shares"; and 98 (98) shares of One Dollar (\$1.00) par value common stock which shall be designated "Class B Nonvoting Common Shares". The Class A and Class B shares shall be entitled in all respects to equal rights and privileges except that each share of Class A shall be entitled to one (1) vote and each share of Class B shall be nonvoting stock.

ARTICLE V Principal Office; Registered Office and Agent

The street address of the principal office and registered office of this corporation is: 3850 Bird Road, Suite 801, Miami, Florida 33146 and the name and adress of the registered agent of this corporation is: Howard Kantrowitz.

ARTICLE VI Board of Directors

This corporation shall have one (1) director. The number of directors may be increased or decreased from time to time by the By-laws, but shall never be less than ONE (1).

- 2. The number of shares of the Corporation outstanding at the adoption was five hundred (500), and the number of shares entitled to vote thereon was five hundred (500).
- 3. The number of shares voted in favor of such Amendment was five hundred (500), and the number of shares voted against such Amendment was none.
- 4. The holders of Common Shares shall exchange one (1) share of such stock for (.004) shares of Class A Voting Shares and (.196) shares of Class B Nonvoting Shares.
- 5. These Amended and Restated Articles of Incorporation were adopted and approved on the 8th day of July, 2016.
- **6.** These Amended and Restated Articles of Incorporation shall become effective immediately upon filing with the Department of State of Florida.
