
ARTICLE VIII

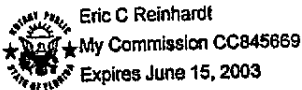
