ARTICLES OF INCORPORATION



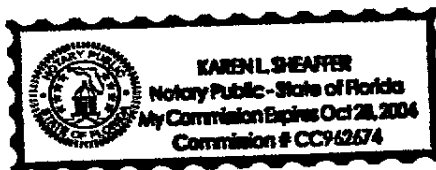
