

ARTICLES OF INCORPORATION

OF

02 HAY 29 AM 8: SECRETARY OF INCOME.

The undersigned incorporator, for the purpose of forming a corporation undersigned the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be: L & T Grading, Inc.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III
