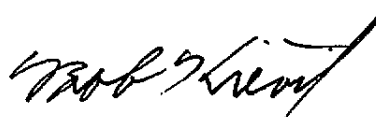

**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be BEE-LINE ALIGNMENT SERVICE, INC.

**ARTICLE II. PRINCIPAL OFFICE**

The initial principal office of the corporation shall be located at, and the mailing address of the corporation shall be, 1614 West Garden Street, Pensacola, Florida 32501.

**ARTICLE III. TERM OF EXISTENCE**

The corporation is to exist perpetually commencing on the date of filing of these Articles by the Department of State.

**ARTICLE IV. CAPITAL STOCK**

The corporation is authorized to issue 10,000 shares of One Dollar (\$1.00) par value common stock.

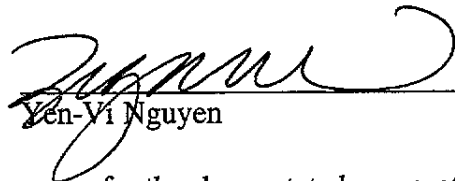

## ARTICLE VIII. AMENDMENT

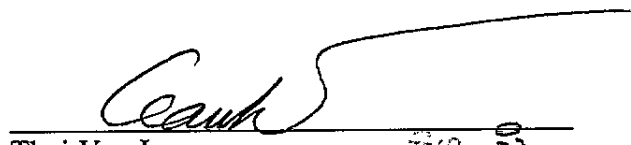
