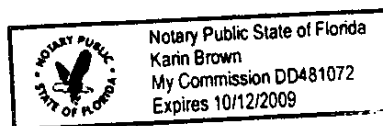
1. Edwin Rios is the President of TPA FLOORING INC., a Florida corporation, (hereinafter "Corporation").
