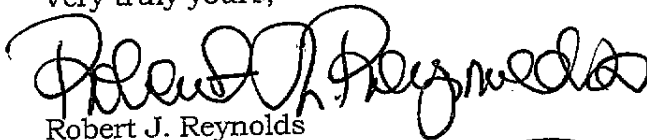

ARTICLES OF INCORPORATION

OF

JND Marketing, Inc.

THE UNDERSIGNED, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of the corporation is:

JND Marketing, Inc.

Article II - Location and Mailing Address

Article III - Purpose

The general purpose for which the Corporation is organized is: business consulting and any and all other lawful business for which Corporations may be incorporated under the Florida Business Corporation Act, the laws of the State of Florida and the United States of America.

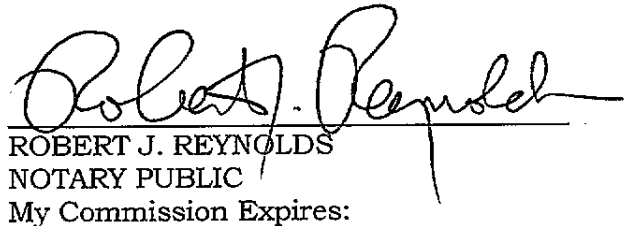
