ARTICLES OF INCORPORATION

ARTICLE I - NAME AND ADDRESS

The name of the Corporation shall be CSI PROPERTIES, INC., with its principal place of business at 2335 Northwest 10th Street, Ocala, Florida 34475.

<u>ARTICLE II - NATURE OF BUSINESS</u>

This Corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States of America, the State of Florida, or any other state, territory, country, or nation.
