The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this for-profit Corporation is Dee's Kitchen, Inc.

ARTICLE II - PRINCIPAL OFFICE


