ARTICLES OF INCORPORATION

ARTICLE 1

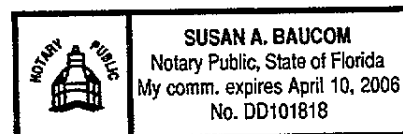
