The undersigned, acting as Incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida.

#### ARTICLE I-NAME

The name of the corporation shall be GRAPHIXATION, INC.

#### ARTICLE II-PRINCIPAL OFFICE

The principal office of this Corporation shall be located at 4200 S. Kirkman Road, #1011, Orlando, Florida 32811.
