The undersigned incorporator hereby forms a for profit corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be as follows:

Onco Ideas, Inc.

ARTICLE II - NATURE OF BUSINESS

This corporation shall engage or transact in any and all lawful activities or business permitted under the laws of the United States of America and the State of Florida; including, without limitation, all activities relating to the practice, advancement and teaching of radiation oncology techniques and modalities, and generally the prevention, treatment and cure of cancer.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having One and No/100 (\$1.00) Dollar par value per share.




