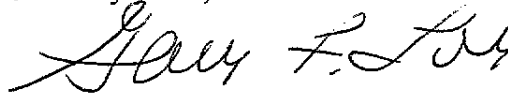

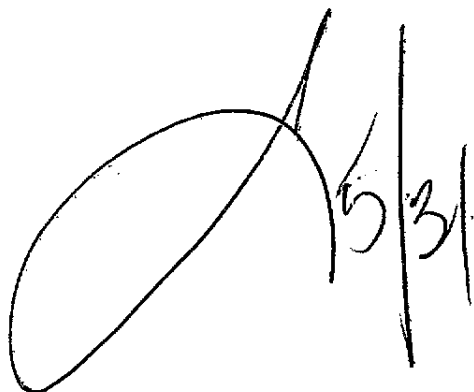

To further common purposes, the undersigned natural person agrees to organize under these Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be Moberg's Motor Coach Services, Inc.

ARTICLE II

ENABLING LAW

This corporation is organized pursuant to the corporation's law of the State of Florida, set forth in Chapter 607 of the Florida Statutes.

ARTICLE III

PURPOSES

The general nature and purpose of this corporation shall be to transact any and all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes.

ARTICLE IV

TERM

This corporation shall have a perpetual existence.
