ARTICLES OF INCORPORATION

OF

EFFECTIVE DATE

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

MARK HARTLEY TRACTOR SERVICE INC.

The name of the corporation shall be: Mark Hartley Tractor Service Inc.

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of June 01, 2002.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:




