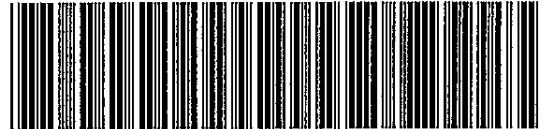

ARTICLE II: ADOPTION DATE OF AMENDMENTS


