

ARTICLE I

NAME

The name of the Corporation is **FLORIDA CRAFT PROPERTIES, INC.**

PURPOSE

The purpose or purposes for which the corporation is organized are to transact any and all lawful business.

ARTICLE III

CAPITAL STOCK
