The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

# ARTICLE I - NAME OF CORPORATION

- All or any portion of the capital stock may be issued in payment for real or B. personal property, services, or any other right or thing having a value, in the judgment of the Board of Directors, at least equivalent to the full value of the stock to be issued as hereinabove set forth, and when so issued shall become and shall be fully paid and nonassessable, the same as though paid for in cash; and the directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock, and their judgment of such value shall be conclusive.
- Notwithstanding the foregoing, the corporation shall have the right to C. increase its capital stock either with or without par value, and to provide in the vent of such increase the designations, preferences, voting powers or restrictions, or qualification of voting powers, of such additional stock, in amendment to its Certificate of Incorporation.
