The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be POSITIVE IMAGE DESIGN, INC. and the business address and location of the Corporation shall be 7801 W. Irlo Bronson Mem. Hwy., Suite E, Kissimmee, Florida 34747.

ARTICLE II

CORPORATE DURATION

This Corporation shall commence to exist upon filing of these Articles of Incorporation. The duration of the Corporation is perpetual.
