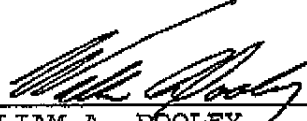
ARTICLE IX - DURATION

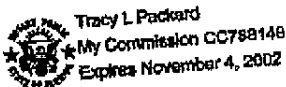

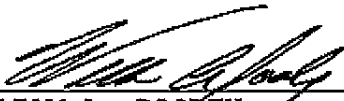

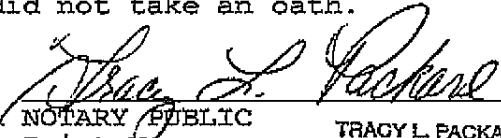
