ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is Maria Garcia-Larrieu, P.A., and its address is: 10380 S.W. 115th Street, Miami, Florida 33176.

ARTICLE II

Duration

The duration of the corporation is perpetual.

ARTICLE III

Purpose

The general purposes for which the corporation is organized are:

(1) To render legal services as provided for under Florida law.

(2) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE IV

Authorized Shares

The aggregate number of shares which the corporation is authorized to issue is 10,000, such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) per share.

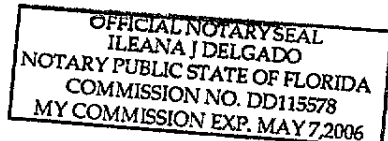
