

The name of the corporation is: **Winter Springs Chiropractic Center, P.A.** The principal place of business of this corporation shall be 1340 Tuskawilla Road, Suite 112, Winter Springs, Fl 32708.

**Article II**

This corporation may engage in chiropractic care as permitted under the laws of the United States, the State of Florida, or any other State, or country.

**Article III**

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.


**Article X**
