**ARTICLES OF INCORPORATION OF**  
**ZEMASO COMPANY**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

The name of the Corporation is ZEMASO COMPANY.

**ARTICLE TWO**

The duration of the Corporation is perpetual.

**ARTICLE THREE**

The general purpose for which the Corporation is for all business which is legal in the state of Florida.

**ARTICLE FOUR**
