I, the undersigned, being desirous of forming a corporation for profit, under the provisions of Chapter 607 of the Florida Statutes, do agree to the following:

**ARTICLE I**

**Corporate Name and Address**

The name of the Corporation shall be: DANCIN' FOR FUN, INC. 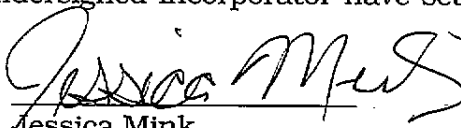

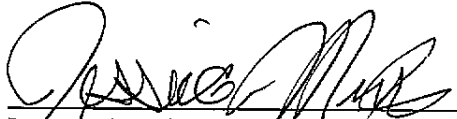
