ARTICLE I-NAME

The name of this corporation is TAMMY GAUTIER, P.A.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting professional real estate services authorized pursuant to ch. 475, Florida Statutes, including services that may be performed as a broker, broker-salesman, or salesperson.

ARTICLE IV-CAPITAL STOCK
