ARTICLES OF INCORPORATION

OF

ANGELA'S TRANSPORTATION, INC.

The undersigned Incorporator to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida in accordance with Section 607.0202, Florida Statutes.

ARTICLE I

CORPORATE NAME

The name of this Corporation is: ANGELA'S TRANSPORTATION, INC.

TERM OF EXISTENCE

This Corporation shall have perpetual existence.

NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the United States and of the State of Florida, specifically including, but not limited to, the non-emergency transportation of patients to and from doctors' offices.

The persons named as Initial Directors shall hold office for the first year of existence of this Corporation or until his successor is elected or appointed and has qualified, whichever occurs first.


