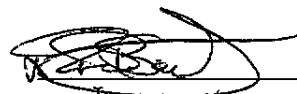
ARTICLE X

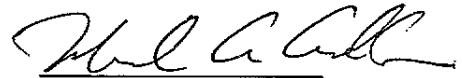

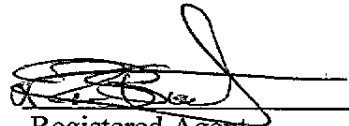
