ARTICLE I - NAME

The name of this corporation is ALUMINUM ARCHITECTURE, INC., with its principal office and address being located at 4332 N.E. 11th Avenue, Oakland Park, Florida 33334.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

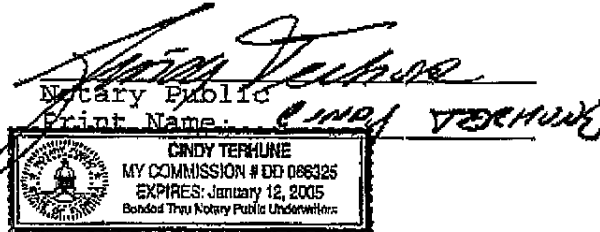
