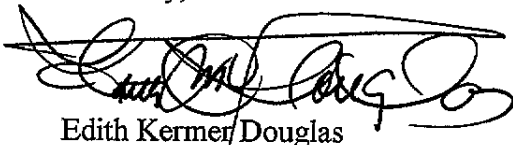

**FIRST:** Amendment adopted: Article VIII, Initial Board of Directors, is amended as follows:

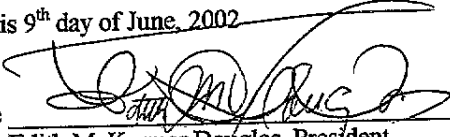
withdraw Leslie K. Kinsey as initial director and
