

ARTICLES OF INCORPORATION

OF

HEADWAY OFFICE PARK, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of this corporation is HEADWAY OFFICE PARK, INC., and its principal place of business is 15600 N.W. 67th Avenue, Suite 308, Miami Lakes, Florida 33014.

ARTICLE TWO

DURATION

The duration of the corporation is perpetual.

ARTICLE THREE

PURPOSES

The general purpose for which the corporation is organized are:
