**ARTICLE I
CORPORATE NAME**

The name of this corporation shall be:

KEVIN SEPE, INC.

**ARTICLE II
DURATION**

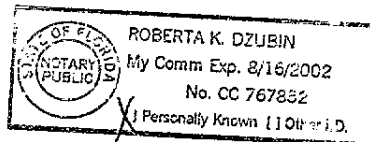
