ARTICLES OF INCORPORATION

OR SUN 3 AM 9:25 In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is D&M ENTERPRISES OF SARASOTA INC.
