#### ARTICLE I

#### NAME

The name of the Corporation is A Native Sun Landscaping, Inc. The principal office address and the mailing address of said Corporation is 30 West  $9^{th}$  Street Atlantic Beach, Florida 32233.

#### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III

#### **PURPOSE**
