## ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be: Avicenna Enterprises, Inc.

Article 2. Principal Office. The principal office of the Corporation is: 10691 – NE 100<sup>th</sup> Lane, Archer, Florida 32618.

The mailing address for the Corporation will be: P. O. Box 1017, Bronson, Florida 32621.
