The undersigned hereby acting as incorporator for the purpose of forming a professional service corporation for profit, by virtue of the provisions of Chapters 621 and 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE 1: NAME AND ADDRESS

MARK A. GOETTEL, P.A., 5623 U.S. 19, Suite 102, New Port Richey, FL 34652.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of Florida.

ARTICLE 3: PURPOSE

This Corporation is organized for the purpose of practicing law within the State of Florida.

ARTICLE 4: CAPITAL STOCK

This Corporation is authorized to issue 7500 shares of \$1.00 par value common stock. 
ARTICLE 8: INDEMNIFICATION

ARTICLE 9: BYLAWS




