

ARTICLES OF AMENDMENT TO O3 APR -2 PM 12: 53 GARDEN SALON AND DAY SPA, INC.

Pursuant to the authority of §607.1003 and §607.1006 of the Florida Business Corporation Act, the undersigned corporation, GARDEN SALON AND DAY SPA, INC. (the "Corporation"), hereby adopts and files the following Articles of Amendment to its currently existing Articles of Incorporation:

- (1) ARTICLE FIRST: The name of the Corporation is presently "Garden Salon and Day Spa, Inc."
- (2) ARTICLE SECOND: Article I of the Articles of Incorporation of the Corporation is hereby deleted in its entirety, and is hereby replaced and superseded by the following replacement Article I:

ARTICLE I <u>NAME</u>

The name of the corporation is Salon Le Jardin & Day Spa, Inc.

(3) ARTICLE THIRD: The foregoing amendment to the Articles of Incorporation of the Corporation was adopted by unanimous written consent of the directors and shareholders of the Corporation as of and effective the 26th day of March, 2003.
