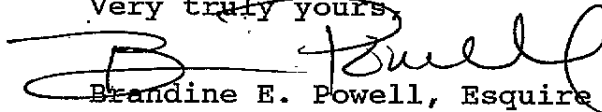

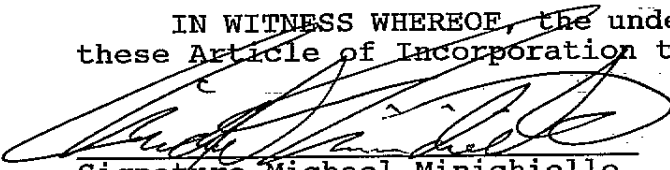

- ARTICLE I: The name of this corporation is **Bulldog Pressure Cleaning Services, Inc.**
- ARTICLE II: The existence of the corporation shall begin on June 7, 2002.
- ARTICLE III: The principal place of business of the corporation shall be 2131 N.W. 76th Terrace, Margate, Florida 33063.
- ARTICLE IV: The maximum number of shares this corporation is authorized to issue is One Hundred (100), all of which shall be common shares.
