

ARTICLE I - NAME

The name of this corporation is **STRIKE FIRST PEST SOLUTIONS, INC.**, located at **1689 Kersley Circle, Heathrow, FL 32746.**

This corporation shall exist perpetually, commencing with the filing of these Articles of Incorporation by the Florida Department of State pursuant to the laws of the State of Florida.

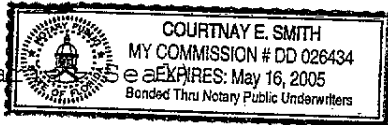
