

**ARTICLES OF INCORPORATION
OF
ELITE PETROLEUM, INC.**

The undersigned Incorporator hereby forms a corporation under Chapter 607 (621 for a P.A.) of the laws of the State of Florida.

ARTICLE I. CORPORATE NAME & ADDRESS

The name of the corporation shall be:


