**NAME**

ARTICLE II

**DURATION**

The duration of the corporation is perpetual. 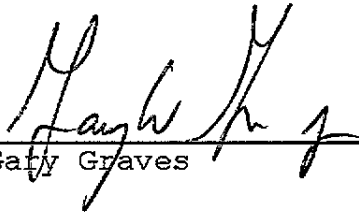
